

# RENTING VEHICLES FROM US TO BECOME A UBER/GRAB DRIVER

Do you want to drive for Uber/Grab but do not own your car? Did you know that you can rent a car and become a Uber/Grab driver-partner? Feel free to read through this useful tip to understand more about this process!

- Why rent from us?
  - a. We are one of Uber & Grab's preferred rental partners. We keep in touch with them weekly in order to fully understand and support their needs.
  - b. We follow all the proper rules & regulations, consulting with LTA as well as our insurance companies with regards to Uber driving. As such, you can drive with ease, knowing that you are covered by the proper insurance, and are not breaking the law.
  - c. All our cars are properly maintained and well groomed. We have our own dedicated workshop to attend to all our vehicles.
  - d. We are located extremely close to Grab's office in Midview City, which enables customers to save a lot of time with regards to registration with Grab. We have dedicated staff who are familiar with the registration process and we can help ensure that the process is smooth and painless.
  - e. We have our own workshop, which means we can dedicate time/effort to attend to all our rental vehicles. We also have our own tow truck on standby in times of need. Furthermore, we are also experienced in handling accidents, and we are able to help our customers with all the paperwork and give proper advice.

We hope that we have caught your attention, and you are now interested to rent from us. Next, please take a look at the following steps to take in order for you to rent a vehicle from us in order to become a Uber/Grab driver-partner.

- Register a company with ACRA. For those who already have a company, to add the business code 49219 to your business activity. The reason we need this step is because of **compliance with insurance & LTA laws**. This is to ensure that the driver & passengers are covered by insurance at all times.
  - a. Visit the following website: <http://www.bizfile.gov.sg>
  - b. Once at the page, click on the “Register Entity” button in the middle (in the “Start Here” section), then choose “Business” from the dropdown list. This will lead you to register a sole proprietorship. You will need your SingPass for this transaction.
  - c. Use 49219 for the business code, and follow the remaining steps accordingly. You will need to make a payment at the end. The cost for registering is \$15.00 for new company name, and \$100.00 for registering the company. Also, you can opt to buy your ACRA profile for \$3.30, to make a grand total of **\$118.30**. After paying, please print out the receipt as well as your ACRA. Uber is willing to refund their customers if you present these to them.
  - d. For those who are adding business codes to their current business, the cost is at \$20.00. Log in with your Singpass and you can update your business profile there.
  - e. For those who prefer hassle-free services, we can apply for a business on your behalf for free!

- Register an account with Uber. Please use our referral code **lb58tue** when creating an account to enjoy a one-time discount off the rental fees. (This discount will be refunded after the driver has completed at least 25 trips)
  
- Rent a vehicle from us. **Our main terms & conditions** are:
  - a. Weekly rental rates (\$340 onwards, depending on vehicle)
  - b. Rental is to be collected in advanced
  - c. No minimum contract of 4 weeks
  - d. We require a minimum 1 week's notification before termination of contract
  - e. We require \$1,000 as a security deposit. This deposit is refundable when the car is returned to us in proper condition.
  - f. Excess liability is \$2,000 within SG, \$5,000 within JB
  - g. We allow instalment plans for the 1<sup>st</sup> week rental, i.e. you only require \$1,000 to drive off with the car. 1<sup>st</sup> week rental can be paid over the next 3 to 4 weeks, along with that week's rental.
  
- **Additional terms & conditions** are stated as follows:
  - a. Hirer must be at least 25 years old and must possess a valid Singapore driving license, and have at least 2 years driving experience.
  - b. Hirer must pump either the min. octane grade required, or octane 95 fuel, whichever is higher. Failure to do so might result in damaging the engine of the vehicle, and Hirer is liable to bear all repair costs.
  - c. Entry into Malaysia is allowed. However, the Owner must be informed before each entry, and there will be a charge of \$30.00/- per day. Failure to declare will result in a penalty of 200% of the fees.

- d. In the event of breakdown/accident within Malaysia, the Hirer is liable to tow the car back to Singapore at the hirer's own expense.
  - e. No smoking is allowed in the vehicle. In the event of smoking, cleaning fees of \$300.00 will apply.
  - f. Hirer must send the car back to the Owner when it is due for regular servicing/maintenance.
  - g. All Uber fare payments & incentives will be made directly to the Hirer's accounts. Hirer is expected to make the weekly rental payments on time (same day of the week as the start of the contract) For all late payments, the Owner reserves the right to levy a late fee fine of \$50 per week, as well as to repossess the vehicle. Towing fee of \$50 will also be payable by the Hirer.
- Once the contract is signed, we will provide you with our vehicle log card, certificate of insurance, as well as a letter from our company stating that you are the driver of the said vehicle. With these, you can proceed to Uber and finish up the registration, and begin driving immediately!
